The Deputy Educational Officer, Tadepalligudem has verified the application of provisional recognition proposals and also with reference to the visit report and also with references to the conditions laid down in G.O.Ms.No.1-Edn (PS-2) Department, Dated:01-01-1994 and submitted his recommendation in the reference 9th read above.

In view of the Circumstances explained and recommended by the Deputy Educational Officer, Tadepalligudem, after careful examination of the references cited and conditions prescribed in G.O. Ms.No.1-Edn (PS-2) Department, Dated: 01-01-1994 the District Educational Officer, West Godavari, Eluru here by accord provisional recognition for the period ten years i.e. from 2007-2008 to 2016-2017 for I to VII Classes to the Vasavi Ideal Public School, China Tadepalli of Tadepalligudem Mandal (Proposed CBSE Syllabus) Mandal without aid subject to the following conditions.

1. that the society shall abide to the rules and regulation made in the Government order cited above.
2. that the society shall provide the necessary amenities like accommodation, sanitary facilities, drinking water facilities, furniture, library, laboratory equipment play field required staff as per the staff pattern and other facilities which are necessary, before approaching the competent authority before applying for recognition.
3. that the society shall apply for recognition immediately duly fulfilling the conditions from time to time.
4. that the permission accorded is restricted to this year only and it is not valid for the subsequent academic year if the Management has not applied for according Temporary recognition as per rules in force.
5. that this permission does not confer any right on the society for claiming recognition
6. that the permission is accorded to Vasavi Educational Academy, Chinatadepalli, T.P Gudem Mandal and no other society or body can open a school on their behalf.
7. that this permission is accorded to open the school in the premises in which the management has submitted documentary evidence only, and there shall not be any change in the premises or locality.
8. the Society shall provide necessary teaching learning material even if it costs more than the deposit amount.
9. to appoint sufficient qualified Teaching Staff and Non teaching staff in the cadre of Attenders, Sweepers, and Scavengers etc.,
10. to Provide suggestion Boxes in prominent places in the School and should provide safe and chlorinated drinking water facility.
